

## **CONTENT LICENSE AGREEMENT**

PLEASE READ THE FOLLOWING CONTENT LICENSE AGREEMENT (“AGREEMENT”) WHICH GOVERNS YOUR RIGHT TO USE THE CASEY LIFE SKILLS TOOLKIT. YOU MUST ACCEPT THESE TERMS BEFORE YOU ARE ALLOWED TO DOWNLOAD THE TOOLKIT. YOU EXPRESSLY AGREE THAT YOU HAVE THE AUTHORITY TO CONTRACTUALLY BIND THE ORGANIZATION AGREEING TO THESE TERMS.

### **Background of Agreement**

**(a)** Casey Family Programs (“Casey” or “Owner”) solely owns all right, title, and interest including copyrights and other intellectual property rights (the “Copyrights”) in and to the Casey Life Skills tools and curriculum, which includes the materials identified in the attached Exhibit A (“Content”).

**(b)** In this Agreement “you” and “your” mean and refer to the organization that is agreeing to these terms and will be using the Content pursuant to the limited license granted herein.

### **Grant of License**

Owner hereby grants you a non-exclusive, non-transferable, limited, non-commercial, royalty-free, worldwide license—without the right to sublicense—to use, copy, reprint, distribute, display, and upload the Content for the exclusive end purpose of administering the Casey Life Skills assessment to assist youth and their families. These rights include the right to make such modifications as are technically necessary to exercise the rights in other media and formats (such as through integration with a case management or child welfare information system), but otherwise you have no rights to modify the Content or make derivative works. You acknowledge that Casey is the sole and exclusive owner of the Content and that you will do nothing inconsistent with such ownership. You agree that nothing in this license will give you any right, title, or interest in the Content other than the right to use the same in accordance with this license.

### **Sharing and Attribution**

If you share the Content other than for purposes of administering the assessment to an individual, you must identify and/or provide attribution to Casey Family Programs as the owner of the Content. If you share or distribute the content digitally, you must do so only by providing a URL or hyperlink to the Content on casey.org.

Upon notice of such replacement sent to the address or contact information provided by you in connection with downloading the Content, or such other address as you may advise us in writing to use, the license for the replaced Content immediately terminates, and this license automatically applies to the replacement Content. You agree not to use the replaced Content for future products and to take all reasonable steps to discontinue use of the replaced Content in products that already exist.
